1. Scholarship for Newcomers(New and Transfer Students)

* School Enhancement Scholarship (for all undergraduate students) If the average score is 3.5, it is equivalent to 50% reduction in the 1st grade by 2.0 improvement.

Notice for Scholarship

- What is the 1)Special Scholarship? Refers to students who receive tuition waiver at the time of admission or enrollment
- Students who completed the PATHWAY in Korean are not eligible for scholarships
- All scholarships are applicable only if 12 credits or more in the semester are obtained and the average score is 2.5 or higher

3. School Scholarship

Eligibility–Scholarships for the previous semester are 2.5 or higher, and 12 credits or more
